7.1 SHIRE OF PLANTAGENET

7.1.1 COMMUNITY EMERGENCY SERVICES MANAGER

A comprehensive training session has just wound up and has enabled more volunteers to progress their training career and advance bushfire safety of our members.

The training is aimed to equip participants with essential knowledge, practical skills and safety measures required to handle bushfire emergencies, structure fires and mobile fires effectively.

The training sessions were highly successful with great participation. Skills refresher sessions have been held at brigade unit level again with great participation. This covered of the Burnover procedures with all of the crew protection functions and pump operations. The practical exercises were particularly well-received, providing valuable hands-on experience in a controlled environment.

Continued training and community engagement will further enhance preparedness and resilience against fire-related emergencies.

7.1.2 RANGER

Calicivirus was released early in October preliminary results are showing a 50% reduction of Rabbit numbers at release sites.

As expected, Plantagenet district has reasonable immunity to the virus.

A different virus strain has been sort and the Shire plan to release in the 2025.

7.1.4 HEALTH

1. Public Building inspection of the Mt Barker evacuation centre conducted during the last week of October 2024

Issue identified

Lack of kitchen for the provision of food on site

Potential solutions

a) Approach could be made to the owners/managers of the CRC to request use of their commercial kitchen, and to local food business owners who have the appropriate risk rated food business registration and Food Safety Supervisor training to run the CRC kitchen in the event the evacuation centre is activated.

Transport of food for immediate consumption would fall well within the 2 hours / 4-hour rule meaning the food won't be out of temperature long enough to become unsafe to eat.

o Refrigerated storage in the form of mobile cool rooms at the evac centre can be used to store pre-packaged foods.

The customer service desk could potentially be used for food service.

b) Approach could be made to local food business owners to see if they'd like to be on a call list for the provision of food, through their business e.g. cafes, pub, caterers, mobile food vans.

This could also work for the provision of food to staff in the event of a protracted incident.

Issues identified

Lack of available private spaces for use by those who require it e.g. women from CALD community, those with sensory processing sensitivities, Dept. Communities referrals quiet spaces.

Potential solution

The large main open area of the centre is bordered by a few fully enclosed and spacious glass fronted areas e.g. squash court, weights room, cardio room. The installation of screens/blinds that can be pulled down when the centre is activated will result in these becoming private spaces.

Attended the DFES CLU (Community Leason Unit) training as an observer on 4 November. I'd like to thank our CESM Mike Barnes, and Charlotte and Mel from DFES for advocating for building the capacity of local government and staff to being able to provide support to emergency services if called upon.

7.2 WA POLICE FORCE

Over the next few months Mount Barker Police Station will have a few officers' off on Annual Leave rotating during the school holidays. We will also be assisting Cranbrook Police Station as they have one officer on light duties.

Mount Barker Police & Albany Police assisted with initial road closures for a fire in Narrikup.

Are any agencies having issues with communication post the closure of the 3G phone towers?

WA Police have already seen some issues with coverage and I believe this will affect more. It may be prudent to add this issue to any exercises in the near future, as we have seen similar issues in the Goldfields earlier in the year.

As a result, Starlink is being fitted to all vehicles and at the back the station for back up.

29 October 2024 - One finding in relation to the incident is that when Police resources are requested for road closures, we need to complete the request form identifying which powers are to be utilised as a matter of priority.

This aids officers in having clear direction as to how the Roadblocks are to work. I am happy to speak with all the relevant Fire Authorities to run through the documents prior to the upcoming fire season.

7.5.1 COMMUNITY PARAMEDIC

Meeting operational requirements while also providing support to Cranbrook, Kojonup, and Katanning mainly with interhospital transfers. Rocky Gully's meeting requirements also assisting the Frankland River area.

Two new clinical volunteers for Mount Barker.

Completed a restructure in November, now considered a district instead of a region. The former Region Manager Tony Melia is not the District Manager and will remain in the area and there are two District Operation Leaders that sit under Tony and are available 7 days a week. No change the Community Paramedic role.

Suggestion put to MBVFR to have a Motor Vehicle Accident (MVA) extraction scenario be run in February 2025.

7.5.2 MOUNT BARKER SUB-CENTRE

All public access AEDs have been checked, with pads and batteries updated. Some AED storage boxes are sun-faded, making instructions hard to read; this issue is being addressed. The Sub-Centres Admin Officer is contacting private AED holders to ensure regular checks of pads and batteries.

Renovations are underway at the Mount Barker sub-centre, and an ablution block is being added to the Kendenup shed, with plans for tender in January.

The region is facing issues with the shutdown of the 3G network, and phone boosters have been installed in all ambulances. Additionally, plans are being explored to mount Starlink units on Community Paramedic vehicles.

PRIMARY 7.9 DEPARTMENT OF INDUSTRIES AND **REGIONAL DEVELOPMENT**

A reminder to all, DPIRD look after plant and animal biosecurity. There are currently five level 2 incidents ongoing statewide, including the Polly Vacher Shot Hole Borer and a new Queensland Fruit Fly detection, with an incident declared this week in the metro area.

In our region, European Wasps were detected last year in the Napier and McKail areas. The inspector is back in the field, setting and checking traps, but so far, no positive detections have been found.

Soil moisture levels are low. Crops are looking promising so far this season.

All weather stations were upgraded prior to the shutdown of the 3G network. The weather station network is now accessible through the Service WA app, which also features the useful Shark Smart information.

7.11 EDUCATION DEPARTMENT

7.11.1 MBCC AND EVACUATION CENTRE

We have been reviewing and updating our Stand-Alone Bushfire Plan for the college.

Sarah Conlin, DFES Bushfire Risk Management Liaison Officer, assisted in identifying a "suitable alternative site" at the college for shelter in the event of a bushfire.

Our current evacuation point is the Rec Centre. However, in a bushfire scenario, the Rec Centre presents concerns with the louvres – ongoing issue for years have previously been attended to however the internal mechanisms are inaccessible and would not seal sufficiently even if working as they should.

We have identified A Block as a potential alternative evacuation site. A Block is better sealed against smoke, has an internal toilet, and includes a kitchen, making it a more viable option for bushfire shelter. Alternatively, the college may need to designate several SBLs rather than just one.

Since the Rec Centre also serves as the town's designated evacuation point, it may be necessary to address the louvers and improve its smoke sealing to ensure smoke can't get in.

How would it be managed if the community and the school where both to use the Rec Centre at the same time?

Mrs Gardener – Department of Communities would set up the evacuation centre for an incident that is far removed from the centre. If

shelter in place is required, then any evacuation of residents would be to a different centre well away from the incident i.e. if there was an incident in Barker then all evacuees would be requested to go to the Albany Lesure and Aquatic Centre (ALAC). The rec centre would then be available to the college for shelter in place or as a terminus for the buses to evacuate the students as per their Bushfire Plan.

Mrs K Wise – Regarding Pardelup's ability to provide food for an evacuation centre,

Mrs Wise previously attended Department of Communities training, which emphasized that any entity supplying food to the community must be appropriately registered under the Food Act for that activity.

Whilst Pardelup is a registered food business with a HACCP plan, they would need to be specifically registered for food transport (i.e., taking food off-site) in order to provide food to an evacuation centre. Without this registration, the Department of Communities will not permit the provision of food.

7.14 PARDELUP PRISON

Rural Fire Awareness training conducted by Mike Barnes and Derek Jones on 7 November 2024 – 44 staff and participants.

A bushfire exercise was conducted on December 2, 2024, focusing on weekend coverage, as staffing levels are reduced during weekends. The senior management team is approximately an hour away, and there is a two-hour response time for staff from Albany Regional Prison if needed. The exercise also tested bus services from Manjimup, Albany, and Mount Barker, with response times ranging from a couple of hours, except for Mount Barker, which could respond in 25 minutes. The plan would be to not to evacuate Pardelup if avoidable, though still needed to test those services.

Pardelup was recently called upon to assist with fire mop-up operations, and a crew has been approved for external activities. However, it is important to

note that we do not want to set the expectation that the crew will be available to assist every time.

Additionally, Pardelup can't compete with any local business to supply food, there will also be a charge for the meals. Initial capacity is 100 meals and if there is a protracted incident then that could be increased.

Have 12 men at Walpole that assist with refilling the water bombers
